St Lucia Bowling Club offers the following types of membership:

Full: \$165 per annum. These members have full voting and bowling rights and will be registered with Bowls Queensland to play in Club and interclub competitions.

Junior (< 18 years) : \$11 per annum. These members will be registered with Bowls Queensland to play in Club and interclub competitions but do not have voting rights

Non-affiliated: \$77 per annum. Members who can enjoy the Club's facilities and may be invited to Cluborganized social events, charity days or similar occasions. Participation ineligibility pertains to events which lead to District Competitions, Intra-club and Inter-club Competitions. Do not have voting rights on matters pertaining to the sport of bowls.

Student: \$35 per annum. Students enrolled at any approved school, college, university or institution of learning. Members who can enjoy the Club's facilities and may be invited to Club-organized social events, charity days or similar occasions. Participation ineligibility pertains to events which lead to District Competitions, Intra-club and Inter-club Competitions and do not have voting rights.

Social: \$11 per annum. These members may use the bar and other club facilities but may not bowl on the greens and do not have voting rights.

Annual Subscriptions are invoiced to members on 1 June each year and assessed on a pro-rata basis for those who join after this date

Green fees are \$20 per day for organized bowls (social and competition), except for Thursday Twilight bowls which are \$15.

Members are able to practice on the greens at any time without paying a fee.

All fees are inclusive of GST
